

## Jerry's Music Lesson Contract

The following represents the lesson policies for **Jerry's Music**. The lessons are booked in 30-minute time intervals, with students attending their lessons once each week. There is a \$15 registration fee per student at the time of enrollment. We also require a current Visa or Mastercard number to be kept on file. If you do not have a credit card, we require a one month security deposit.

**Tuition** – You must pay the **full monthly tuition to receive the monthly rate** and have a permanent spot in the schedule book. Tuition is due before the first of the month. After the 7<sup>th</sup> of the month there will be a \$5.00 late charge and your credit card will be billed for the monthly tuition plus the late fee. If your card is declined, you will be removed from the schedule and billed for the unpaid lessons.

**Single Lesson** – The single lesson rate is \$35 and must be prepaid.

**Monthly Lessons** – The monthly rate is \$120 for 4 lessons \$150 for 5 lessons (based on \$30/lesson).

**Family / Multiple students** – There is a \$2.50 monthly discount for each student.

**Payment** – Payment must be made before the 1<sup>st</sup> of the month. If you choose autocharge, we will handle the billing and any credits, etc. If you do not choose autocharge all lessons must be prepaid.

**Attendance:** Students are expected to attend their lesson(s) each week. **If you cannot attend a lesson, you must notify us before noon the day of the lesson (Monday through Friday) or before 6pm on Friday for Saturday lessons. All scheduling must be handled by the staff at the front counter of the store.** If cancellation is received before the deadline, you will receive a make-up lesson. Cancellations must be rescheduled within 15 days, and are subject to availability. Jerry's Music allows a maximum of 2 cancellations per month. Any additional cancellations will be forfeited. If Jerry's Music cancels a lesson, you will receive a pro-rated credit. The credit can be used toward the next month's tuition. If your teacher cancels, we will supply a substitute. If we are unable to, we will give a credit.

**Refunds:** Jerry's Music will not refund tuition for lessons cancelled by the student. Make-up lessons due to student cancellation cannot be used in lieu of regular scheduled lessons.

**Termination:** This contract will automatically renew each month and will remain in effect until written notice is given at least 24 hours in advance of your intent to terminate or in the case of nonpayment.
